Waiver, Release, Indemnity and Promise Not to Sue

My child/athlete(s), _____, wish to participate in the Allatoona JR Bucs 2020-2021 Wrestling Season scheduled to take place at the campus of Allatoona High School during the period of November-February.

I fully recognize that certain risks are involved in participating in the Activity and in being transported to and from the campus and other ¹ incidental places, and I voluntarily assume those risks.

My child will wear protective clothing and equipment as appropriate, follow directions of the employees and agents of Licensee and engage in the Activity in a prudent and cautious manner. I will not (i) act in any way which shall interfere with the lawful running or operation of the Activity or equipment used in connection with the Activity or (ii) engage in any type of conduct, which contributes to or causes injury to any person.

I am responsible for all of my own loss, liability and expenses, including medical expenses in connection with the activity, including any Covid-19 related issues that may arise. I have no physical, mental, psychological or medical condition that would prohibit me from participating or materially increase the risk to me or others of my participating in the Activity. I have adequate insurance to cover any medical expenses for any injuries that may arise out of the Activity. I hereby authorize the employees and agents of Allatoona Wrestling, at their discretion, to administer to or seek for me first aid and other emergency medical services and transportation for further medical care, but I acknowledge that they may not be present or may not elect or be able or competent to administer or seek such aid or services or transportation.

I will not hold Allatoona Wrestling or Allatoona High School and their respective trustees, officers, employees, agents, students or volunteers responsible for any injury I might incur in connection with the activity, including any Covid-19 related issues that may arise. I will not sue or seek damage in any form, and I hereby waive and release any and all claims against Allatoona Wrestling and Allatoona High School for personal injury, arising in any way out of my participation in the Activity and agree to indemnify, defend and hold Allatoona Wrestling and Allatoona High School harmless from any such claims. I recognize that this release means I am giving up, among other things, rights to sue any party including Allatoona Wrestling and Allatoona High School for injuries, damages or losses I may incur.

I have read and do understand the above statements and they are true and accurate. The signing of this Waiver, Release, Indemnity and Promise Not to Sue is completely voluntary.
