**A current physical on the 2023-2024 Cobb County Physical Form is required no later than March 29**th. If you already have a current physical on file at Allatoona High School, please indicate this on the Cheerleader Candidate Information Form (page 12). All candidates that are placed on a squad will need to obtain a NEW physical dated <u>AFTER April 1st</u> on the 2024-2025 Cobb County form AND upload it to Synergy ParentVue before they will be permitted to participate in any events, conditioning, etc. This is a COBB COUNTY policy!

Again, YOU MUST HAVE A PHYSICAL by March 29<sup>th</sup> or you will not be able to tryout- NO EXCUSES.

#### **SQUAD SELECTION PROCESSES**

### NEW- This year, each cheerleading is required to cheer a minimum of two squads.

## Varsity Football/Competition Squad:

All grade levels are eligible to try out for the Varsity Football/Competition squad. The selection process for the competition squad will be based on filling the positions required for a successful competition squad. As with any competition squad, it is imperative that every position be covered; therefore, the squad will consist of the following individuals: **4 flyers**, **8 bases and 4 back spots**.

The individuals who qualify for one of the above spots (provided tumbling requirements are met) will be one of sixteen squad members. GHSA only allows **up to** 16 individuals to perform at a given competition, therefore, every position is critical and squad chemistry is a must. ALL members of the Varsity Football/Competition squad will attend practices, competitions, and cheer at Varsity Football games.

IMPORTANT NOTE: Alternates for the competition squad will be selected during tryouts and named on our final squad. They will cheer Friday nights with Varsity. For competitions, they will be REQUIRED to compete with the JV Competition squad unless they are pulled up to fill/replace a spot on the Varsity floor. The only exception is if you are a SENIOR alternate who cannot cheer down on the JV Competition squad per GHSA rules.

### Junior Varsity Football/Competition Squad:

Grade levels 9<sup>th</sup>-11<sup>th</sup> are eligible to try out for the Junior Varsity Football/Competition squad. The selection process for the competition squad will be based on filling the positions required for a successful competition squad. As with any competition squad, it is imperative that every position be covered; therefore, the squad will consist of the following individuals: **4 flyers, 8 bases and 4 back spots**.

The individuals who qualify for one of the above spots will be one of sixteen squad members. GHSA only allows **up to** 16 individuals to perform at a given competition, therefore, every position is critical and squad chemistry is a must. ALL members of the Junior Varsity Football/Competition squad will attend practices, competitions, and cheer at Junior Varsity Football games.

#### Each cheerleader candidate will be scored based on the criteria detailed below:

- Cheer: Motion technique and sharpness.
- Dance: Timing, rhythm and motion technique.
- Jumps: Toe touch and one other jump of choice.
- Standing Tumbling
- Running Tumbling
- Stunting Ability
- Appeal: Showmanship and genuine spirit.
- Sportsmanship: Attitude and participation during tryouts.
- Appearance: Correct clothing and hair pulled back off the shoulders (in a pony tail).

## Varsity Basketball Cheerleading:

All grade levels are eligible to try out for the Varsity Basketball squad. Must have a sideline presence, good voice projection, rhythm for cheers, and no stunting or tumbling is required.

#### Varsity Game Day Competition:

All grade levels are eligible to try out for the Varsity Game Day squad. Game day squad may not have more than 24 cheerleaders. Must have a sideline presence, good voice projection, rhythm for band dance/fight song, basic stunt knowledge, and standing tumbling is a bonus (BHS/Tucks only).

Squads will be formed based on scores compiled from a panel of judges, fulfillment of the paperwork requirements, teacher feedback, and ultimately-coaches' final decision.



### ALLATOONA HIGH SCHOOL – CHEERLEADING POLICIES

#### **PURPOSE**

The purpose of the Allatoona High School Cheerleading Program is to promote and uphold school spirit, develop a sense of good sportsmanship among students, and to strive for better relationships between schools during all athletic events.

#### I. GENERAL OBJECTIVES

Cheerleaders are student athletes and must strive to achieve the highest standards both academically and physically. Cheering at Allatoona High School is a privilege, **NOT** a right.

#### II. SQUADS

Cheerleaders will report <u>directly to their coach</u> for all matters. Cheerleaders are "on the job" <u>all year long</u>. Cheerleaders are often asked to assist in school functions and activities other than the seasonal sport. <u>These functions are mandatory</u>.

#### III. UNIFORM RENTAL & UNIFORM PURCHASE

Some uniforms will be rented to cheerleaders by Allatoona High School. The rental fee is nonrefundable. The fee is used to help with the upkeep and maintenance of the uniforms and/or to purchase new uniforms. If a uniform does not fit, it may be altered – but NOT cut. Alterations are included in the rental fee and will be organized and handled by the Booster to protect the longevity of the uniforms.

**Note:** Returning cheerleaders are **NOT** guaranteed the same uniform in consecutive seasons.

<u>Varsity Competitive Uniform</u>: We purchased a new uniform in year 2022-2023. Every Varsity Competitive cheerleader will need to purchase, but once you purchase a new uniform will not be needed until 2025. We will be getting a new competition cheer uniform every 3 years. Once you are done, you can sell it or keep it. For the 2024-2025 season, it will be the last year of the competition VARSITY uniforms. New uniforms will be bought in the 2025-2026 season.

#### **IV. BEHAVIOR AND DISCIPLINE**

As a member of the Allatoona Cheerleading Program, you are expected to maintain behavior above reproach because you are a leader in the school. Consequences for violating any regulation in this constitution will be at the discretion of the coach and will be handled according to the rules of Allatoona High School, the Georgia High School Association, and Cobb County policy. Please keep in mind the following:

- Any behavior, which is deemed by the coach as reflecting poorly on the intended image of the program no matter where the incident takes place is subject to dismissal from the program at the coach's discretion. This includes, but is not limited to, pictures on Facebook, Instagram, Snapchat, TikTok, or Twitter, wearing uniform in public without coach's permission, inappropriate behavior in public (even if not in an Allatoona uniform or practice clothing).
- Cheerleaders who receive ISS will not be allowed to participate in any cheerleading activity during the assigned ISS period.
- Cheerleaders who receive OSS will not be allowed to participate in any cheerleading activity during the assigned OSS period and will be *subject to immediate dismissal at the coaches' discretion*.
- <u>DEMERITS</u>: We will be continuing our DEMERIT system for the 2024-2025 season that will be shared at the parent/cheerleading meeting AFTER they make a squad. Please note, after a certain number of demerits the cheerleader is *subject to immediate dismissal at the coaches' discretion*.

#### **V. TRANSPORTATION**

Cheerleaders will travel to and from football games by bus when the school provides a bus. Some exceptions may be made for competitions. Competition cheerleaders must coordinate transportation home from competitions (including the State competition in Macon, GA). Varsity Game Day will have a bus provided to and from the school for competition and state (location TBD). Varsity Basketball Squad will only do home games. We will travel for playoff games and that is when we will attempt to request a bus.

#### VI. ELIGIBILITY

Cheerleaders MUST...

- Pass three out of four classes each semester and be on track academically towards graduation at the end of the year.
- If a cheerleader quits or is terminated, he/she will not be allowed to try out the next year or attend the end-of-the- year banquet. *Exceptions to this may be granted at the coaches' discretion*.

Please note, coaches will be getting weekly grade reports. If we feel as if the athlete needs to attend academic lounge during lunch or focus on tutoring before a practice, we will recommend that. They are STUDENT athletes; their education comes <u>FIRST</u>.

#### **VII. VARSITY LETTERS**

To be eligible for a varsity letter, a cheerleader must be on any Varsity squad and meet the following requirements:

- You must complete the entire season. Those dismissed from the program for any reason will not receive a letter.
- Cheerleaders may not order a varsity jacket until her commitment for the entire year is completed.
- In ADDITION, the coach must recommend the cheerleader for their letter. This means that the cheerleader must demonstrate a positive attitude, work well with her teammates, be respectful, and give 100% all of the time.

All coaches' decisions are final.

#### **VIII. ATTENDANCE POLICIES**

As a member of the Allatoona Cheerleading Program, you are required to contribute your part. When one person is absent the whole squad suffers and causes ineffective practice time. As a result, the following attendance rules are necessary and will be enforced:

- Cheerleaders MUST schedule appointments and work schedules around all cheerleading activities. Note:
   Cheerleading duties are often scheduled with little advance notice. Early release from or late arrival to practices and/or performances is unacceptable.
- Cheerleaders **MUST** be present at all practices, performances, fundraisers, pep rallies, sign painting sessions, camps, competitions, and any other activities designated by the coach.
- Excused absences are:
  - Death in the family.
  - Signed doctor's excuse that indicates time and date of the sickness or injury.
  - School-related trips.
  - Any other excused absences are at the <u>discretion</u> of the coach and will be addressed on an individual basis. These absences <u>MUST</u> be approved by the coach <u>at least 24 hours prior</u> to the missed practice, game, competition, or event.
- If a cheerleader is seen by a doctor for an injury that affects her ability to cheer, a signed doctor's note must be submitted to the coach. (THIS **IS MANDATORY**.)
- As a high school athlete, it is the responsibility of the <u>cheerleader</u> to communicate directly with the coaching staff regarding any attendance issues.

ANY ABSENCE FROM A PRACTICE, GAME, COMPETITION, OR EVENT WITHOUT NOTIFIYING YOUR COACH 24 HOURS PRIOR TO THE DAY OF THE PRACTICE, GAME, COMPETITION, OR EVENT IS SUBJECT TO IMMEDIATE DISMISSAL AT THE COACHES' DISCRETION.

Attendance issues will fall under our DEMERIT policy that will be later discussed once athlete makes a squad.

#### IX. COMMUNITY SERVICE COMMITMENTS

All cheerleaders are required to participate in **AT LEAST 20 hours** of community service that directly impacts the Allatoona High School community. This includes, but is not limited to, volunteering at the Pickett's Mill Spring Fling in April, visiting local middle/elementary schools on the Friday mornings of the varsity home games, working charity events hosted at Allatoona High School, such as participating in Shop with a Buc in December, moving mats from school to school, helping Coach Gratzer, conducting Youth cheer practices/events, or helping with any other Allatoona Cheerleading events.

#### X. PARTICIPANT APPAREL/ACCESSORIES

**NFHS Spirit Rules Book**: These are rules with which all schools in the state are required to abide.

Art. 1... A coach must not permit a squad member to participate if in the judgment of the coach, the participant does not conform to the NFHS rules.

Art. 2... Jewelry must not be worn except for religious medals, which shall be taped to the body (without a chain) under the uniform.

(This includes <u>all</u> piercings. It is acceptable to use a plastic plug to prevent holes from closing up. New piercings are vulnerable at practices when we are stunting. <u>Since jewelry is not allowed piercings should be done in the off-season. Covering an earring with a bandage is NOT acceptable.)</u>

- Art. 3... Unduly long fingernails, including artificial nails, can become a safety hazard. Therefore, fingernails, including artificial nails, must be kept at a length appropriate to minimize risk for the participants. (In addition, only clear polish can be worn at games/competitions/events.)
- Art. 4... The hair must be worn in a manner to minimize risk for the participant. (Ex. Off the shoulders)
- Art. 6... Glitter ...on one's ...hair, face, uniform, costume or body is illegal.
- Art. 8... Participants are not permitted to chew gum or have candy in their mouths during practice or performance.

#### **XI. FINANCIAL RESPONSIBILITIES**

Every attempt will be made to cut down on the personal costs to the cheerleader. All fees are non-refundable. If a cheerleader quits or is removed for any reason, a refund cannot be issued. **Please note that all prices listed below are approximate and do not include tax, etc.**

#### **Explanation of Fees:**

- (1) The uniform rental fee is used to help with the upkeep and maintenance of the uniforms, such as alterations, dry cleaning, replacement piece, etc. It is also used to purchase new uniforms at the coaches' discretion. Uniforms will not be distributed until any previous balance has been paid in full (or a payment plan has been established).
- (2) The booster club fee helps cover the costs of items such as, but not limited to, bank/credit card fees, tax return preparation, spirit materials such as tape, banner paper, paint, award costs for cheerleaders, coaching fees/wear, etc.
- (3) The athletic fee is to cover fee charged by Allatoona High School Athletics Department.

- (4) The hospitality fee helps cover theme nights, game day meals, bonding events, end of season gifts, etc.
- (5) The team photo fee will cover Neil Nigrelli Photography which will include a competition squad photo, banner and digital image.
- (6) The competition uniform fee covers the cost of a new competition uniform for each cheerleader. New competition uniforms will be purchased every 3 years.
- (7) Team practice wear includes 3 tanks, 3 sports bras and 3 shorts/skirts.
- (8) The senior fee helps cover senior flowers, sash, senior breakfast/event, senior gift, etc.
- (9) New cheerleader fees are for cheerleaders new to the program. If you cheered with Allatoona previously, these items are optional or purchased to replace previously purchased items if damaged or lost.
- (10) Fundraising/Volunteer Duty: Every cheerleader is REQUIRED to participate in ALL fundraising & volunteer duty activities. Scheduled fundraisers include but are not limited to: Group Fund, Little Bucs Cheer Camp, Raffle, Corporate Sponsorships, and other fundraising activities to be determined during the season. Every cheerleader is REQUIRED to physically participate in Little Bucs Cheer Camp (4 days TBD from 7:30am-12:00pm) and the Buc Bash Cheerleading Competition (all day). Every parent is REQUIRED to work 8 hours of volunteer opportunities during the season with 4 hours being volunteered at Buc Bash. The parent volunteer opportunities will be outlined at the beginning of the season. Parent volunteer opportunities include activities such as working Little Bucs Cheer Camp or Buc Bash, moving mats, etc. A \$350 fundraising/volunteer duty deposit check is due at fittings on April 18, 2024. If the cheerleader and parent work their required hours, the fundraising/volunteer duty deposit check will be destroyed or returned at the end of the season. If the cheerleader and parent do not work their required volunteer hours, the fundraising/volunteer duty deposit check will be cashed at the end of the season.

# ALLATOONA HIGH SCHOOL EXPLANATION OF INHERENT RISKS FOR CHEERLEADING

Cheerleader Candidate's Full Name:

Cheerleading is an exciting, time-consuming sport that involves flyers, bases, and spotters. Flyers are lifted into
stunts by the bases, with the safety-oriented spotters when needed. Bases and spotters are responsible for
catching the flyers when the stunts come down. Cheerleading also requires forceful motions, tumbling, voice
projection and jumping. The cheering area varies greatly from one location to another, inside or outside.

Because of these conditions inherent to the sport, participating in cheerleading exposes an athlete to many risks of injury. Those injuries include, but are not limited to: death, paralysis due to serious neck and back injuries, brain damage, damage to internal organs, serious injuries to the bones, ligaments, joints, and tendons, and general deterioration of health. Such injuries can result not only in temporary loss of function, but also in serious impairment of future physical, psychological, and social abilities, including the ability to earn a living.

In an effort to make cheerleading as safe as it can be, the coaching staff will instruct athletes concerning the correct techniques for stunts and rules of cheerleading. It is vital that athletes follow the coach's skill instructions, training rules, and squad policies to decrease the possibility of serious injury.
